MEMORANDUM OF UNDERSTANDING (MoU) BETWEEN DEPARTMENT OF
DEFENCE AND NATIONAL SECURITY STUDIES (DDNSS),
PANJAB UNIVERSITY, CHANDIGARH AND INSTITUTE FOR DEFENCE
STUDIES AND ANALYSES (IDSA), NEW DELHI.

The Institute for Defence Studies and Analyses, New Delhi and Department of Defence and National Security Studies, Panjab University, Chandigarh, hereinafter referred to as two sides:

Taking into account the need for developing academic ties, mutually beneficial exchange programs and furtherance of academic research, have agreed upon the following:

Clause I

The objective of the MoU is to establish academic and scholarly ties between the two sides and cooperate in the sphere of academic research on security, defence, socio-economic and technological issues in the international, regional and national domain.

Clause II

In order to work towards full realization of ties between the two sides the following forms of cooperation will be adopted:

- Exchange of ideas through conduct of seminars, discussions and conferences.
- Cooperation in conduct of:

- (i) Student and Research Scholar Exchange programme
- (ii) Doctoral programme
- (iii) Faculty exchange programme

- Publications and academic research work of IDSA will be made available to DDNSS, Panjab University by way of copies of IDSA Publications, periodicals and enabling online access to IDSA website at no cost.
- The IDSA will accept Students, Research Scholars from DDNSS, Panjab University for internship programs held at IDSA from time to time subject to their eligibility and availability of vacancies with the IDSA.
- Both sides will encourage visits of delegations/delegates to each others premises for exchange views on security, defence, technology and socio-economic issues.
- Both institutions will mutually confer adjacent faculty / honorary faculty positions and have joint supervision of PhD Scholars registered at DDNSS, Panjab University.

Clause III

In order to promote cooperation and exercise maximum financial restraint, both sides agree that financial implications of any exchange program or interaction will be discussed mutually on a case to case basis.

Clause IV

This MoU will come into force on the date and its signing. The MoU will remain valid for a period of two years from the date of signature till reviewed or extended by mutual consent.
