Prof. Harvinder Singh, Secretary, Faculty of Design and Fine Arts welcomed the House and read out the following agenda:

The faculty considered and approved the recommendations of the Board of Studies in Architecture and Planning meeting dated 18.05.2017 that the outlines of tests, syllabi and courses of reading of B. Architecture (1st to 10th Semesters) for the Session 2017-18, 2018-19, 2019-20 will as per Appendix (Page 1-152)
2. The faculty considered and approved the recommendation of the Under Graduate Board of Studies in Music meeting dated 12.03.2018 that the outlines
